

30825QLD Course in the Safe Erection/ Installation of Swing Stage Scaffolds

Overview

This course covers the functions required to safely erect and install swing stage scaffolding.

This course is required under the new Scaffolding Code of Practice 2009 (Workplace Health and Safety Queensland) and will meet the implied licensing requirements outlined in the Scaffolding Code of Practice 2009

Entry Requirements

Participants must:

- Be at least 18 years of age or older.
- Hold a Licence as an Advanced Scaffolder and/ or
- Hold a licence as an Advanced Rigger.
- Have at least an intermediate level of numeracy, literacy and communication skills.

Delivery

Formal training and theory assessment for this course is delivered between two (2) and three (3) days of face-to-face classroom and practical activity sessions. *N.B. The length of the course depends on the existing level of experience of participants.*

Units of Competency

There is one (1) unit of competency associated with this course:

- QLD330SCF01A Safe Erection/ Installation of Swing Stage Scaffolds

Outcomes

Completion of the Course in the Safe Erection / Installation of Swing Stage Scaffolds will equip participants with the necessary vocational skills to enhance their existing advanced scaffolding and/or rigging training and meet licensing/ regulatory requirements Australia-wide. Locate, interpret and apply relevant information, standards and specifications, plan the job.

It is expected that competent participants should be able to:

- Effectively communicate and work safely with others in the work area.
- Effectively apply risk assessment and hazard management procedures at an advanced scaffolder and advanced rigger level.
- Effectively complete the planning, installation, commissioning and dismantling of swing stage scaffolding systems in accordance with procedures and appropriate standards.
- Effectively use safety harness and travel restraint systems.
- Complete handover certification as required.

Upon completion of all training and assessment associated with this course, participants will receive a Statement of Attainment in the completion of *30825 Course in the Safe Erection/ Installation of Swing Stage Scaffolds*.
