

## 30826QLD Course in the Safe Use of Swing Stage Scaffolds

### Overview

This course covers the functions required to safely use a swing stage scaffolding.

This course is required under the new Scaffolding Code of Practice 2009 (Workplace Health and Safety Queensland) and will meet the implied licensing requirements outlined in the Scaffolding Code of Practice 2009

### Entry Requirements

- Nil – No formal prerequisites/ entry requirements as knowledge of the techniques gained by completion of the course will assist participants to avoid injury.

### Delivery

Formal training and theory assessment for this course is delivered between one (1) and one and a half (1.5) days of face-to-face classroom and practical activity sessions. *N.B. The length of the course depends of the existing level of experience of participants.*

### Units of Competency

There is one (1) unit of competency associated with this course:

- QLD330SCF02A Safe Use of Swing Stage Scaffolds

### Outcomes

The outcomes of this training will equip participants with the necessary vocational skills to safely use Swing Stage Scaffolds and to meet implied licensing/regulatory requirements.

It is expected that competent participants should be able to:

- Comply with OHS legislation regarding the use of Swing Stage Scaffold
- Effectively communicate and work safely with others in the work area.
- Effectively identify hazards associated with the operation of a swing stage scaffold and apply risk assessment and hazard management procedures.
- Effectively determine Working Load Limits
- Effectively use safety harness and travel restraint systems.
- Effectively conduct swing stage scaffold operations including tasks of lowering and raising in conjunction with awareness of the limitations of the swing stage scaffold according to the manufacturer's specifications.
- Ensure swing stage scaffold controls are attended throughout operation.
- Effectively conduct emergency lowering of the swing stage scaffold according to the emergency procedure.
- Effectively conduct pre-operational and post operational checks of swing stage scaffold (particular awareness of controls, alarms and particular safety devices).

Upon completion of all training and assessment associated with this course, participants will receive a Statement of Attainment in the completion of *30826 Course in the Safe Use of Swing Stage Scaffolds*.

### **Assessment Requirements**

Participants will be required to successfully complete a series of assessment tasks which will include a written assignment, knowledge exam and practical skills performance assessment.

### **Recognition of Prior Learning (RPL) / Credit Transfer**

Prospective participants may be eligible to receive RPL or credit transfer depending on whether they have any previous industry experience or hold existing qualifications. Applicants should speak with CSTC prior to course commencement to discuss these options further.
